SUBJECT: covid-19 vaccination plans

Formal NOTICE AND DEMAND are hereby served upon you immediately
to cease and desist any and all further plans to inoculate all
enlisted South African personnel with any vaccines ostensibly
designed to immunize them against alleged covid-19 exposure(s).

Your specific performance must be demonstrated by announcing your
compliance with this lawful NOTICE AND DEMAND no later than the
deadline of 72 hours Friday December 10th, 2021.

Your failure to perform as required will provide the Undersigned,
and the People of South Africa on whose behalf
the Undersigned proceeds ex relatione, with probable cause to
take all appropriate and lawful action to enforce this DEMAND, in
a court of competent jurisdiction.

The Indian Bar Association is reporting that murder charges have been filed in India's High
Court against two billionaires responsible for the AstraZeneca's COVID-19 vaccine,
Covishield, for the murder of a 23-year-old man who was injected with the shot.

The two named defendants are Bill Gates, and Adar Poonawalla, the CEO of Serum Institute
of India (SII), reportedly the world's largest vaccine maker. According to corporate news

sources, Adar Poonawalla's company produces not only the COVID-19 vaccine Covishield, but also over 50% of the world's vaccines that are injected into babies.

The unnamed defendants are "other Government officials and leaders involved in the murder of a 23 year old man, who lost his life because of vaccination."
